Students

Our school's current enrollment is 54 students, with an overall mid-second quarter attendance rate of 94%. Ms. Stephanie's 4/5 grade class is once again leading the way with 98% attendance rate. Galileo Assessment #2 has been completed with a positive increase for the majority of our students. We are in the initial talks with the organization ChildHelp- Speak up be safe through state provided grant monies, with an emphasis on an anti-bullying campaign and keeping children safe with a voice.

We had over 100 people/students in attendance for our annual Veterans Day Luncheon, a huge success and a great time for all. I would like to express my sincerest gratitude to all of those community members who continue to donate items such as turkeys, art supplies, jewelry for kids to give as presents and many monetary awards to our school to assist with enhancing our library and future field trips to the AZ Science Museum. In addition, a shout out to community members Dean, Harley and Carl for continued assistance with our swings and our almost completed outdoor sand volleyball area. We are currently assisting the Bouse Museum with handmade Christmas tree decorations, via 1940's theme

Maintenance

Our fire drill was completed for the month of November. Bus and school vehicle maintenance is up to date, with a follow up appointment in Phoenix on December 22nd for our bus. Representatives from The Trust and our insurance carrier have now both completed onsite visits with me and Cassandra. Our 2 new roof A/C units have now been installed with 100% reimbursement coming via the Arizona Schools Facilities Department.
