5. Superintendent's Report-

Students

Our school's current enrollment is 60 students, with an overall 3 rd quarter attendance rate of 94%. Ms. Stephanie's 4/5 grade class is once again leading the way with 97%. Spring Break is next week, with a student return date of Monday, March 18th. Administration will maintain normal business hours for Spring Break. State AZELLA reassessment testing is now completed. We will assess our newly enrolled ELL students after spring break. Galileo Assessment #4 has been completed with a positive increase for the majority of our students.

Maintenance

Our fire drill was completed for the month of February. Representatives from The Trust and our insurance carrier have now issued the final report for my review. I am in the process of in-house repairs to address any outstanding issues, in addition to scheduling outside contractors for those items needing more specialized attention. We have been awarded a school improvement grant of \$157,000 (up from the original award of \$132,000) from the State of Arizona- Project Momentum as a result of committing to the project for two years for Teacher Leadership monies, substitute coverage, Professional Development, Data Support, Project Oversight, ELL Intervention and AZELLA Testing, Interventionist, Instructional Coaching for teachers, and off contract pay over the summer and additional Fridays during the academic year for teachers as well as virtual PD's.
