#### Students

Current School Attendance average is 95%, up from last month 94%! Picture day occurred on October 4th for the entire student body and staff. Parent/Teacher Conferences are occurring all of this week, with the end of 1st quarter and report card on Thursday, October 5th. Fall break is October 9th- 12th. The Student Council is now finalized for the school year, with speeches and elections completed.

Upcoming events for the month of October include the La Paz County Health Dept. being onsite for flu shots on October 18th. Students/Staff participating in the annual Red Ribbon Parade on Saturday, October 21st. The Bouse Halloween Carnival is scheduled from 5:30-7:30 on Thursday, October 26th.

#### Improvements

New K-8 ELA Curriculum has been purchased including the online licenses, with teacher training scheduled for November. School property septic tanks and grease traps have now been emptied, this should eliminate issues within the school. Terms and conditions for our two new roof air conditioner units are now completed, and the overall state process is underway. Continued work on the exterior grounds continues with lawn valves and timers being replaced, trimming of trees, removal of dead shrubs. Preparation for a school auction to the public is being considered in 2024 for expired, replaced and unused items as property and building cleanup continue as well.
